ELECTRIC CAR CHARGING

There are now more than 35,000 charge point connectors across the UK in over 13,000 locations – that's more public places to charge than petrol stations, with around 7,000 charge point connectors added in 2020 alone and the biggest increase was in the new ultra-rapid chargers.
